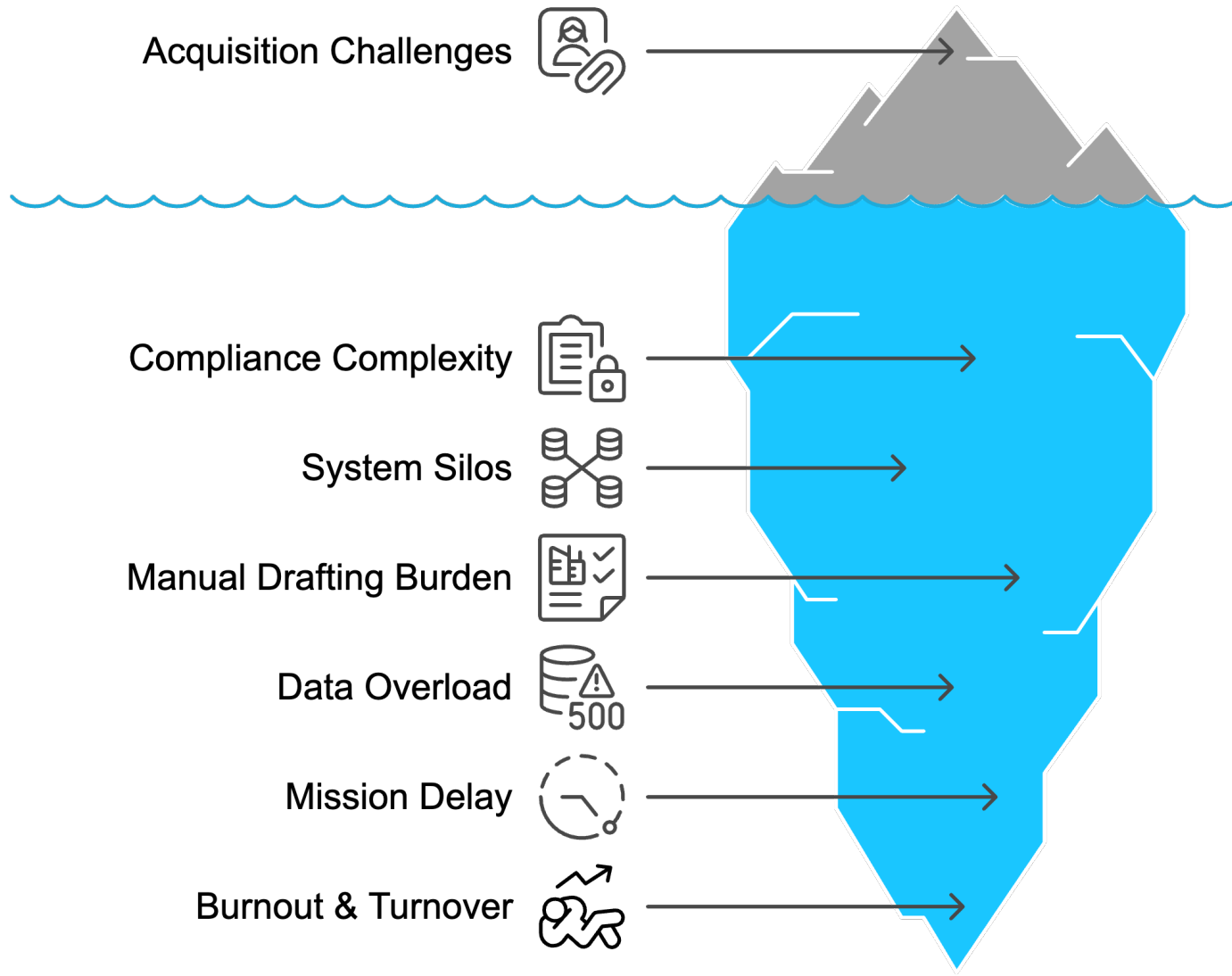

Defense Needs

“Underinvestment in maintaining the acquisition workforce in the 1990s has weakened the workforce’s capability to manage an increasingly complex acquisition system.”

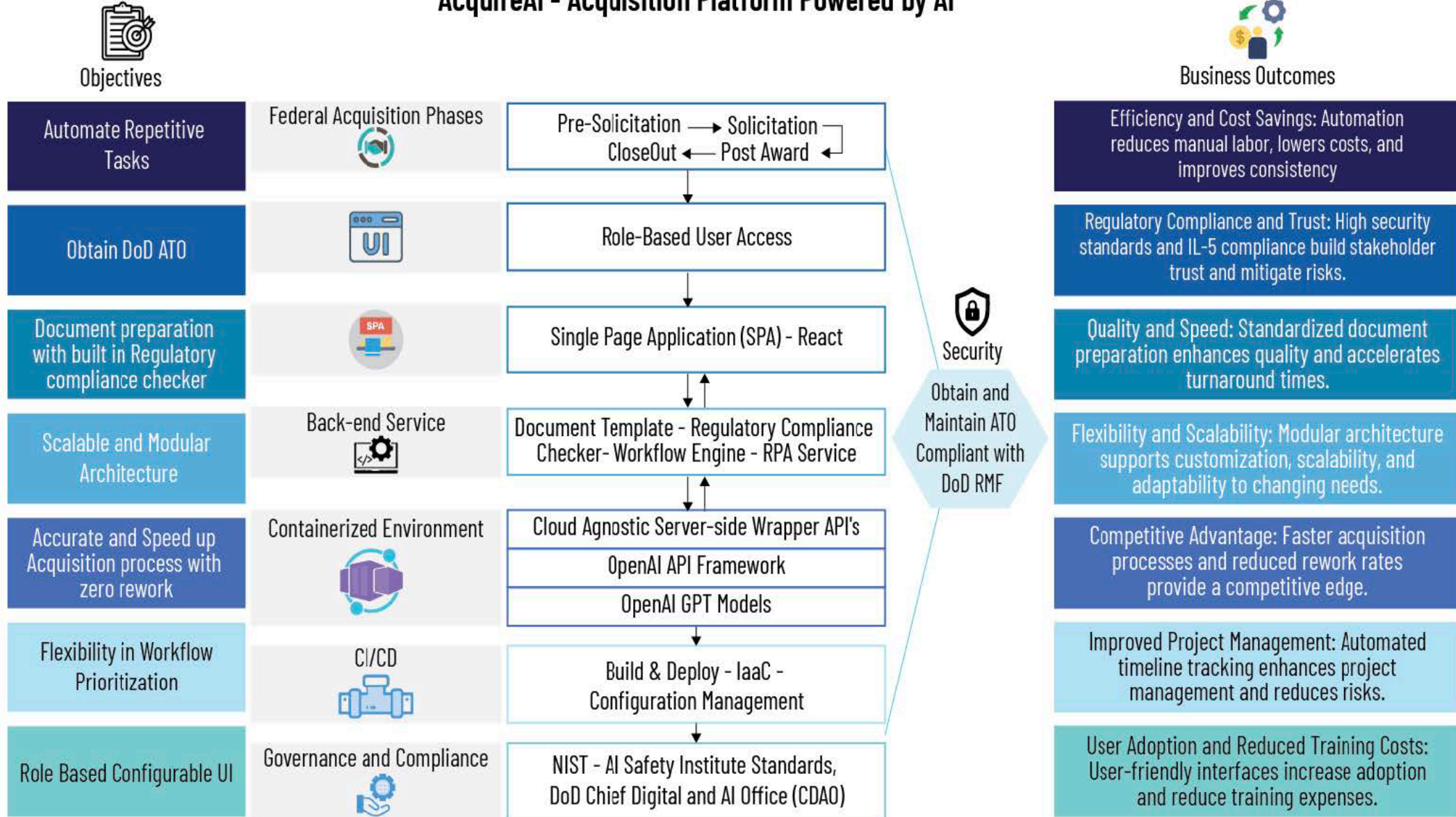

Value Proposition & Core Capabilities

AcquireAI ensures accuracy and adherence to FAR (Federal Acquisition Regulation) compliance by leveraging generative AI for document creation, accelerating federal agencies' procurement activities. It streamlines the document creation process and enhances visibility into their documentation and acquisition procedures. Additionally, it will assist agencies in identifying the necessary documentation for specific types of procurements or acquisitions. Ultimately, we envision the platform as a one-stop shop for all documentation needs related to federal acquisitions.

A library of acquisition templates that users can use and refer



Generate Acquisition Tasks

Generate a task list using AI for the user based on the high-level information.



Progress tracking

Keep a track of all the necessary documents needed for the acquisition

Provides a "virtual analyst" for vendor intelligence gathering.

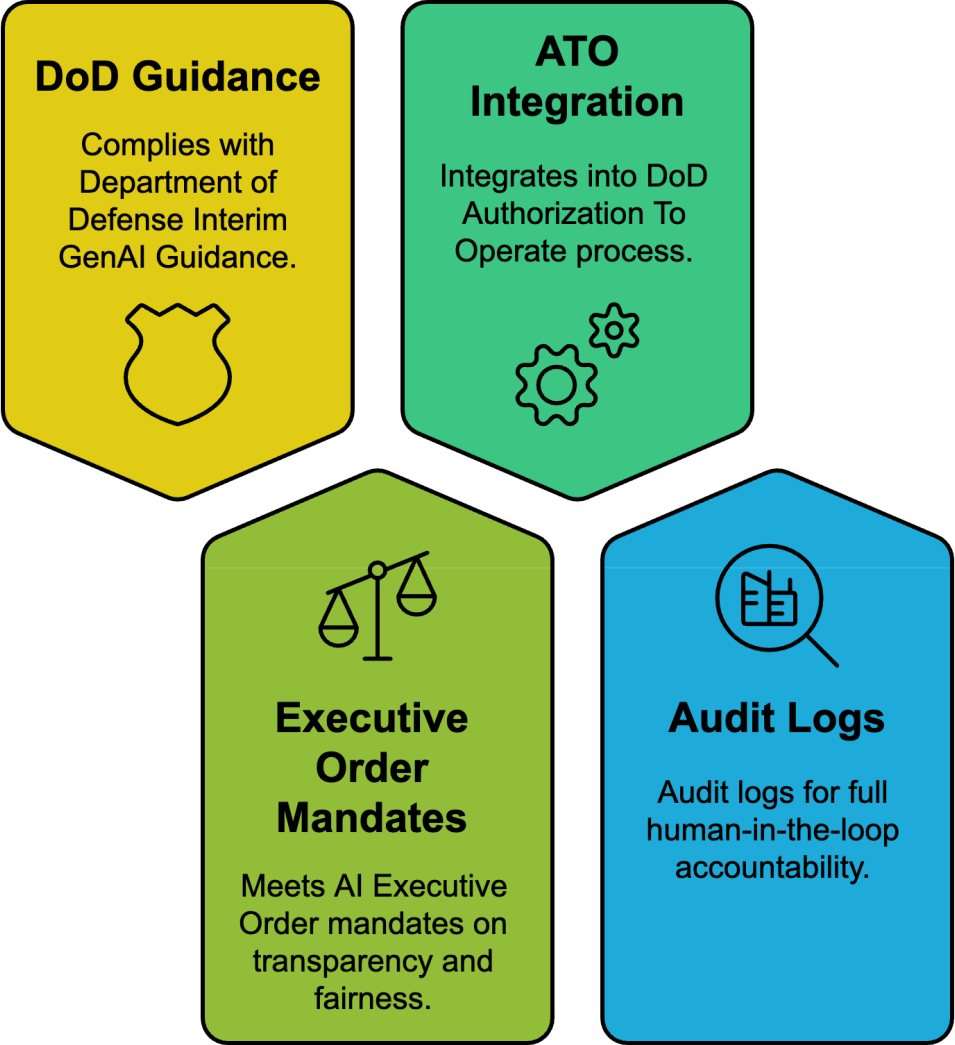
Proposal Screening
